Proceedings:-

The Hon'ble MMIC (SWM) presided over the meeting and welcomed all members. The agenda items were then taken up for discussion.

(A) Uttaran Services Department proposals:-

**1. Proposal for construction of new roadside urinal (Gents) at 48 BK Pal Avenue, Ward -20, BR-II:-**  
The Committee permitted the proposal, subject to:-  
Clearance from the Parks & Squares Department and the Survey Department.  
Final approval from the Hon'ble Mayor, as the matter involves policy-level decisions.

**2. Proposal for construction of new Pay & Use Toilet at 1 Ultadanga Road, Ward no-12, BR-II:-**  
The Committee approved the proposal, noting that adequate facility planning beyond a 500m radius should be ensured.

**3. Proposed area for construction of Pay & Use Toilet near 5/2 Rafi Ahmed Kidwai Road, Ward -51, BR-VI:-**  
The Committee did not recommend the proposal, citing space constraints and non-feasibility.

**4. Proposed construction of Pay & Use Toilet beside Abhisar Shopping Complex, Ward -106, BR-XII:-**  
The Committee advised inspection by the Survey Department and recommended that the proposal be considered only upon obtaining necessary clearances/NOC. An alternative site may also be explored.

**5. Construction of Women Toilet Complex cum Baby Care Room near Alipore Zoo (Main gate) Ward - 74, BR-IX, Under Kolkata Dash Diganta Scheme:-**

The Committee permitted the proposal, subject to:-  
Ensuring that a minimum clear footpath width of 2.0m is maintained.  
Considering pedestrian congestion in the area and adopting space-efficient design.

**(B) CME (C) Department Proposal:-**


**1. Installation of Mother Teresa Statue in front of Mother House (54A AJC Bose Road, Ward -62, BR-VD):-**  
The Committee recommended the proposal in view of its cultural and heritage significance.

**2. Execution of Shed in front gate of community hall at 1/5 Raja Dinendra Street, Ward -28, BR-IV:-**  
The Committee recommended the proposal.

**3. Proposal to be placed before Footpath Committee in connection with Dish Washing Facility:-**  
The Committee permitted the proposal, subject to prior inspection and technical assessment by the P & D Department.

**4. Seeking permission from authority to allow encroachment of footpath and road related with proposed construction of KMC Health Centre at 21 Hazi Md Mohsin Square of Ward -62, BR-6:-**  
Committee is not authorized to consider the encroachment of blacktop road. In the specific case, encroachment of road is proposed which is outside the scope of the committee, hence the proposal is dropped.
