Sub: Submission of the proposal for construction of new toilet blocks through the web portal.

Madam/Sir,

As discussed in the webinar held on **17th February 2025** with all ULBs regarding the submission of proposals for the construction of new toilet blocks (implementation of CSAP 3A), Hijli Inspiration, the third-party organization engaged by SUDA to verify compliance, was also present. After detailed deliberations, the following decisions have been made:

1. SUDA has developed a web application for the submission and sanctioning of new toilet block construction proposals. The workflow of the portal was explained during the webinar. Therefore, it is now requested that all proposals for new toilet block construction be submitted through the web portal, accessible via the link provided below:

2. **The username for logging into the portal will be the respective ULB codes used for logging into the Swachhatam portal, and the default password will be "12345678"**. ULBs are requested to log into the portal, navigate to the proposal section, and submit their proposals by filling in the required data and uploading the necessary documents as per Annexure-II, which was shared earlier.
3. To date, we have received approximately **1,820** new toilet block construction proposals from **88 ULBs** out of a total of **128 ULBs** in the State. The details of these **1,820** toilet blocks must also be entered into the web portal no later than **28th February 2025**.
4. It is requested that from now on, all proposals be submitted exclusively through this portal for further necessary action. Kindly refrain from submitting proposals in hard copy or via email.

Matter is extremely urgent.
