Sub: Your request for NOC regarding inclusion of the tribal settlements of Pearsonpalli, Kaligunge and Balipara (located in Visva- Bharati campus) in the jurisdiction of extended Bolpur Municipality.

Madam,

With reference to above, I would like to inform you that the University, vide its earlier letters dated 15.02.2008, 23.06.2015 etc, have already informed its in-principle "no objection" to the inclusion of the tribal hamlets of Balipara, Pearsonpalli and Kaligunge located in Visva-Bharati campus (in lands owned by Visva-Bharati in khatian no 270 of mouza Surul-104), within the jurisdiction of the Gram Panchayat.

However, it was then decided mutually by the State Gov't and Visva-Bharati, that the tribal residents being technically unauthorized occupants of Visva-Bharati's lands (originally acquired by the Gov't of Bengal vide LA case no 4 of 1927-28), resumption/ relinquishment of the said Visva-Bharati lands in favour of the State Government would be effected first.

Since no progress on the resumption/ relinquishment proposal has been made since January 2017 and it may take some time, the tribal residents of the aforesaid 3 (three) hamlets in Visva-Bharati campus may now be provided civic services by bringing the hamlets under the jurisdiction of the (extended) Bolpur Municipality, if the Government so wants. However, there should be a basic demarcation of the area brought within municipal jurisdiction, so as to segregate that area from the rest of our campus.

We understand that in addition to inclusion of the area in the municipal jurisdiction, it is imperative to grant the tribals some kind of rights over the lands so that they can truly avail socio-economic benefits (including housing schemes for the poor) under Government schemes.

For this, we will need specific support from the district land authorities in the following matters:

1. Finalizing a map of the area to be resumed (through the committee formed by the District Magistrate, Birbhum vide order dated 05.12.2008).
2. Assisting Visva-Bharati in preparation of the relinquishment proposal.

The aforesaid Committee formed by the District Magistrate may be revitalized so that the map of the area to be resumed is finalized in consultation with all stake holders.



Sub: Addendum to and submission of relevant documents in respect of our objection dated 23-12-2019 regarding delimitation of wards/extension of Bolpur Municipality.

Madam,

We thank you for the patient hearing given by you to our officers today.

We are also thankful to you for providing us copies of the UD & MA Department's notifications dated 20-11-2017 and 8-8-2018 as requested by us in our objection letter

A. On examination of the said two notifications, we have found some discrepancies. However, we will limit our observations to those errors only that affect Visva-Bharati campus:

- (i) In these two notifications, the full mouzas of Ballavpur (63), Goalpara (65), Boyradihi (66), Shyambati (67), Madhusudanpur (68), Taltore (69), Bandhgora (100), Surul (104) have been shown to be part of Ruppur GP and they have been transferred in full to the extended Bolpur municipal jurisdiction, but only portions of these mouzas were under Ruppur GP. Portions of Visva-Bharati campus falling under these mouzas have always been outside Ruppur GP, vide Gov't gazette notifications made in the 60s, 70s and 80s. In this respect, I request you to examine the order 35 dated 11-01-2013 made by the then District Magistrate & District Panchayat Election Officer. Copy of the said order, along with background papers are submitted herewith as Annexure-A (13 pages). We will submit the 60s/70s/80s gazette notifications also, if required by you. SIDA and Bolpur SDO's office have files on this subject.

- (ii) In another serious discrepancy in the said UD& MA notifications (20-11-2017 and 8-8-2018), the sheet no 1 of Bolpur (99) mouza and several individual plots including 792,790,788,706,707 etc have been shown as part of Raipur Supur GP and proposed to be added to the extended Bolpur Municipality. However, the sheet number 1 or these individual plots are not part of Raipur-Supur GP, they never had any connection with Raipur -Supur GP. Jurisdiction line of Raipur-Supur GP ends at least 2 kilometres away from these plots, which are within Visva-Bharati campus.
- B. We are also submitting herewith copies of our earlier correspondences showing Visva-Bharati's objection against inclusion of our campus in Bolpur Municipality including the objection given in November 2012 during the conception of this extension proposal by the sub-divisional administration. (Annexure-B, 8 pages).

Sub: Objection against your Notice no 2197 (14)/Elec dated 16-12-2019 read with Resolution dated 16-12-2019 of the B.O.C. of Bolpur Municipality, notification nos 568/MA/O/C-4/IM-15/2015 dated 8-8-18 of the Dep't of UD & MA, no 1029/MA/O/C-4/IM-5/2004, Pt-II dated 18-11-2019 of the State Election Commission, no 1004-SEC/IE-95/2019 dated 26-11-2019 of the State Election Commission, no 2169 (6)/Elec dated 4-12-2019 of the District Municipal Election Officer & DM, Birbhum.

Madam,

This is to inform you that Visva-Bharati has objections to the proposed delimitation /expansion /reorganization/ merger etc of the Wards of Bolpur Municipality as contained in your Notice dated 16.12.2019, read with Resolution dated 16.12.2019 of the B.O.C. of Bolpur Municipality and other notifications/ orders etc referred to above in as much as that certain portions of Visva-Bharati campus have been proposed to be included in the extended jurisdiction of Bolpur Municipality without consulting Visva-Bharati which is a statutory body with a well delineated campus of 1130 acres or 4.5 sq kms and a resident population of 7000.

While we are examining in details the full implications of your Notice read with the aforesaid Resolution and other notifications, three or four illustrations would suffice to bring out the discrepancies in the proposed delimitation/ extension/ merger etc.

1. In Para (१५) of the Resolution of the BOC, it has been proposed that Doordarshan Kendra (LR plot no 792), Akashbani Bhavan (LR plot nos 790 and 788) and Fire Brigade Office (LR plot nos 706 and 707) are to be included in the Bolpur Municipality as added area of the Ward no 3. Our comments on para " १५ " are as below:

1/3

i. (Doordarshan Kendra, Akashbani Bhavan and Fire Brigade Office etc are all located within Visva-Bharati campus on plots (LR 792,790,788,706 and 707 etc) owned by Visva-Bharati and these three organizations are our lessees/ settlees. They cannot be treated as separate landmarks or entities as part of the (proposed) municipal jurisdiction without affecting Visva-Bharati which surprisingly has not been mentioned at all in para (. Cf) of the resolution. In other words, Fire Brigade, Doordarshan, Akashbani Bhavan etc have been treated as separate entities but Visva-Bharati has not been treated as an entity.

(ii) Plot no 706 and 707 (owned, as they are by Visva-Bharati) are not contiguous to the existing municipal jurisdiction (Ward no 03). In between the present municipal jurisdiction and plot nos 706 and 707 there are other plots which are part of Visva-Bharati campus and where we have our own installations (residential quarters, office etc).

2. In the proposed Ward no 20 & 21 also (Refer para " ५६ " of BOC resolution dated 16-12-2019), several areas of Visva-Bharati have been included in isolated manner without considering the issue of contiguity of the extended municipal jurisdiction and the all important integrity of our campus.

3. If this delimitation and expansion plan is implemented, Visva-Bharati campus will be divided into disjointed parts where some portions will be within municipal governance and some portions will not be under the jurisdiction of any local body at all.



(i) For example Indira Gandhi Centre, Doordarshan, staff quarters in Visva Bharati campus within Bolpur mouza have been included in the proposed extension, but our Central Administrative Building, Central Library, PM Hospital etc (LR plot no 491,492,494,501 etc of Bolpur-99), China Bhavana, Hindi Bhavana, Chhatimtala etc (LR Plot no 59 to 76 of Bolpur-99) have not been included.

(ii) Also, for example Visva Bharati's asrama ground, Girls' Hostels (Birlalaya, Goenkalaya, Srisadana, Ananda Sadana etc) Kala Bhavana, Sangit Bhavana located asrama area in Bandhgora-100, have not been included in the proposed extension but our Kala-Sangit Hostel in neighboring plots of the same mouza have been included. All these defy contiguity and logic.

4. As you are aware, Visva Bharati has a large campus of 1130 acres, well demarcated in maps prepared by the Directorate Land Records and Surveys, Govt of West Bengal in 1968 and 2008. Main residents of the campus are boarders (approx 4000) in 32 hostels and staff (in 500 residential quarters). There are some residential lessees (approx 500 population) also. Therefore, it is not understood why certain parts of Visva-Bharati campus have been found to be useful for inclusion in Bolpur Municipality and certain parts have not been found so.

5. We have been consistent in our opinion that parts of Visva-Bharati campus should not be included in isolated / haphazard manner in any local body and that Visva Bharati and adjoining areas having a different character in terms of demography, livelihood, physical and cultural features etc, a separate urban body named Santiniketan should be formed for these areas.
6. For this, we have given representations to the honorable Chief Minister, Urban Development Department, State Election Commission, SDO and others in the past 11 years. We have also attended hearings in the District Magistrate's chamber in recent past. The matter has been discussed in the Apex Advisory Committee on Santiniketan, chaired by the Chief Secretary.
7. Similar isolated inclusion was made before 2013 Panchayet Elections also but due to our objection and as a result of hearing held by the then District Magistrate, the inclusion was cancelled.
8. We have repeatedly made our views known to the Urban Development and Municipal Affairs Department and the district authorities in the last two years also.
9. Considering the gravity of the issue, kindly allow us time until 07.01.2020 to file detailed objections to this notice read with notifications /orders etc referred to above. Kindly allow us a hearing on this matter in the second week of January 2020.
10. We also request you to provide copies of notification no 568/MA/O/C-4/IM-15/2015 dated 8-8-18 of the Dep't of UD & MA, notification no 1029/MA/O/C-4/IM-5/2004 pt-II Kolkata dated 18-11-2019 of the Urban Development & Municipal Affairs Department, notification no 1004-SEC/IE-95/2019 dated 26-11-2019 of the West Bengal State Election Commission, notification no 2169(6)/Elec dated 04-12-2019 of the District Magistrate, Birbhum

No. 568/MA/O/C-4/1M-15/2015, dated Kolkata, the 8th August, 2018 – WHEREAS the Governor expressed his intention vide notification No. 733/MA/O/C-4/1M-15/2017, dated 15th day of November, 2017, published in Kolkata Gazette Extraordinary on 20th day of November, 2017 (hereinafter referred to as the said notification) for inclusion of fifteen contiguous local areas of Bolpur Municipality (hereinafter referred to as the said Municipality), constituted under the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) (hereinafter referred to as the said Act), namely - Ballavpur (part), Kabi Mohanpur, Goyalpara, Bairadihi, Shyambati, Madhusudanpur, Taltore, Dakshin Chandipur, Uttar Radhanagar and Surul under Ruppur Gram Panchayat, Bolpur (part), Shibpur and Chandanpur (part) under Raipur-Supur Gram Panchayat and Gayespur (part) under Sian-Muluk Gram Panchayat, which have been constituted under the West Bengal Panchayat Act, 1973 (West Ben. Act XLI of 1973) and Bandhgora (part), (hereinafter referred to as the said area) within the jurisdiction of the Bolpur in the district of Birbhum consisting of the land as described in the Schedule below under clause (c) of section 9 of the said Act;
