Release Order

Pursuant to the Administrative Approval and Financial Sanction (AA and FS) issued vide no.SUDA-954/2021/6182 dated 30.07.2025 in favor of **Jalpaiguri Municipality** for construction of **21 (Twenty One)** toilet blocks under the City Sanitation Action Plan (CSAP-3A) for Toilets under SBM-U 2.0 and as per the accepted rates received by the ULB and followed by closure of bids and issuance of work orders for **20 (Twenty)** Toilet Blocks, an amount of **Rs.4971481** (Rupees Forty Nine Lakhs Seventy One Thousand Four Hundred Eighty One Only) as 1st installment (i.e., 30% of the aggregated accepted amount) is hereby released.

- The work may be supervised by the Nodal Officers and Nodal Engineers, SBM from the ULB along with the Nodal Coordinator from IFA (Hijli Inspiration).
- Post construction, the constructed toilet blocks must conform to be all the criteria of the model estimates shared and as per the mandatory conditions mentioned in the Swachh Certification Protocol of SBM-U 2.0.
- The toilet blocks are to be uploaded in Swachhatam portal (<https://admin.sbmurban.org/u/login>) of MoHUA, GoI as well as in CSAP-3A portal (<https://csapthreaa.codydeasoftech.in>) launched by the State.
- Copy of the Utilization Certificate of 1st installment released is to be submitted for further release of funds in next phases.
