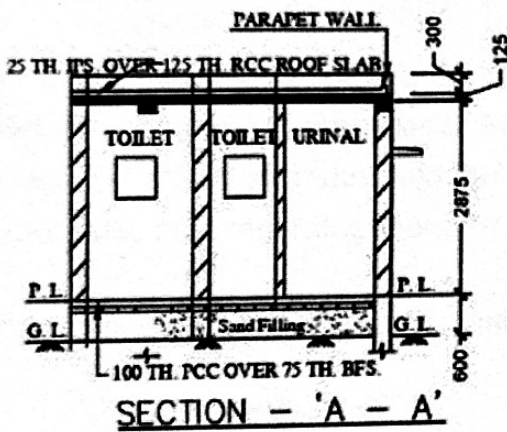
**MODEL DRAWING FOR CONSTRUCTION OF C. T./P.T.

MODEL NO.- G**



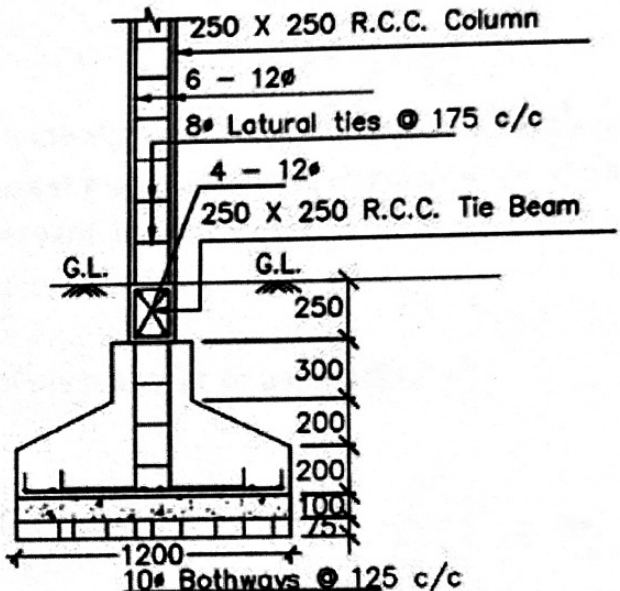
**FRONT ELEVATION**



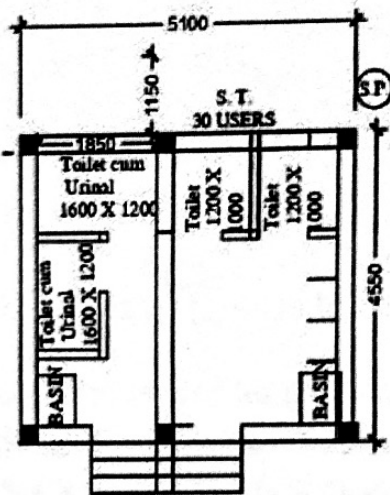
**Details Of R.C.C Roof Slab & Beam


