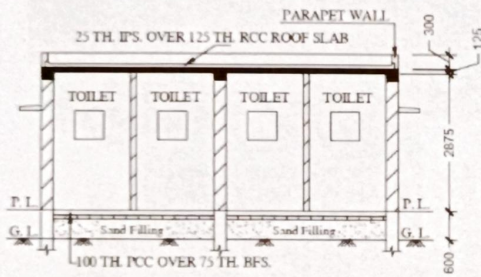


FRONT ELEVATION

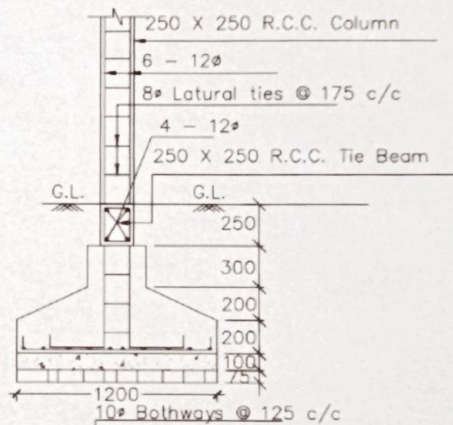
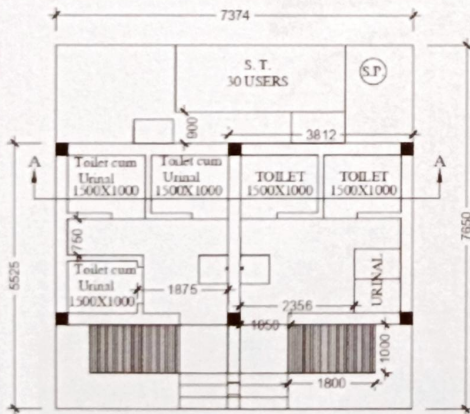


Details Of R.C.C Roof Slab & Beam
